DUTIES:

The Communications Squadron Senior Enlisted Leader is responsible for representing the commander to the enlisted workforce and vice versa, while also managing resources and ensuring the unit executes its mission effectively. They act as a bridge between the commander's vision and the enlisted personnel's needs and concerns, ensuring the unit is well-trained, equipped, and organized to accomplish both state and federal missions. Key duties include: representing the commander to communicate goals and directives to the enlisted force, ensuring everyone understands the mission and priorities. Advocates for enlisted personnel representing the views and concerns of the enlisted workforce to the commander, ensuring their voices are heard and addressed. Executing the mission by ensuring the unit is capable in its assigned mission(s) including training, equipping, and organizing personnel. Managing resources through the efficient and effective uses within the squadron, including personnel, equipment, and funds. Improving the unit by identifying areas within the squadron and implementing changes to enhance performance and efficiency. Supervising and training airmen to ensure they are proficient in their respective roles and meeting the standards of excellence. Maintaining communication effectively within the squadron, both internally and with other units and agencies. And by serving as a role model for other Airmen, demonstrating the Airman Leadership Qualities and upholding the highest standards of conduct and professionalism.

QUALIFICATIONS:

- Must be a United States Citizen
- Must meet the minimum physical requirements
- Must be able to obtain at least a Secret Security Clearance
- No convictions for alcohol, financial or behavioral related incidents, or law violations other than traffic
- Minimum Rank: E8 promotable to E9
- Must have a current and passing PT score
- Must be worldwide qualified (both deployment and assignment) and not have a permanent assignment limitation code "C3"

EVALUATION PROCESS:

Complete applications must be received by COB on closing date.

COMPLETE APPLICATIONS INCLUDE:

- Current RIP (within the last 6 months)
- ASVAB scoring with minimum of M:45 and E:60
- AF 422
- Last 3 EPR/EPBs
- MyFitness Report (or equivalent fitness report)

- Cover letter and Resume
- Letters of Recommendation (3 max)
- Official Biography (Optional)

CROSS TRAIN ELIGIBLE AIRMEN:

- Must attend AFSC awarding school within 1 year of selection
- Must be willing to incur additional service commitment requisite with attending AFSC awarding school
