

**STATEWIDE VACANCY ANNOUNCEMENT (SWVA)  
STATEMENT OF AGREEMENT**

1. I understand that promotion is dependent on MOS qualification. If I am not MOS qualified at the time of selection, I have 1 year from the date of selection to become qualified. Requests for extension of this requirement will be considered on a case by case basis by the State G-1. If at the time of selection for this position I am on the current EPS list (regardless of CPMOS) I will not be considered for promotion until I become MOSQd and appear on the EPS list in the new CPMOS (sequence number is irrelevant).

If I am NOT on the current EPS list, I will not be considered for promotion until I become MOSQd and appear before the next scheduled promotion board. Once I appear on the EPS list in the new CPMOS (sequence number is irrelevant), and meet all other promotion eligibility criteria, a request for promotion can be approved.

2. I further understand that I have one year from the date of selection to attend the required NCOES for the position grade, if I am not already qualified. Extensions to this one year requirement can be granted for ALC only if training seat availability, mobilization, or other administrative processing requirements prevent the Soldier from attending within the allotted time. Mobilized Soldiers may be eligible for NCOES waivers of WLC per AR 600-8-19, paragraph 1-27d (1). However, all other requests for ALC and SLC waivers have been eliminated per ARNG-HRH Policy #11-029, Enlisted Personnel Policies in Support of the Army Leader Development Strategy.

Upon completion of the required NCOES for the next higher grade, I must appear before the next scheduled promotion board. Once I appear on the EPS list in the new CPMOS (sequence number is irrelevant), and meet all other promotion eligibility criteria, a request for promotion can be approved.

3. I understand that I must meet the required TIG and TIS of the position grade. If I do not currently meet the requirement, I will not be considered for promotion until I meet the requirement and appear before the next scheduled board. Once I appear on the EPS list in the new CPMOS (sequence number is irrelevant), and meet all other promotion eligibility criteria, a request for promotion can be approved.

4. I understand that the position is over 50 miles from my residence (if applicable).

5. Failure to meet any of the above requirements can result in reassignment to a position commensurate with my current grade and CPMOS. If I am authorized by my command to remain in the position I have been selected for, I will be required to meet all regular promotion criteria provided in chapter 7 of AR 600-8-19 (i.e. be at the top of the CPMOS list to be eligible for promotion).
